1 INTRODUCTION

1.1 ABOUT THIS DOCUMENT

The *Micronic Tube Reader DT510* incorporates a housing with a 2D symbology reader, which is connected to the scanner via a USB cable. The scanner reads and decodes 1D rack barcodes and 1D barcoded and 2D Data-Matrix coded tubes. The *Micronic Tube Reader DT510 package* contains:

1.3 INTENDED USE


- The *Micronic Tube Reader DT510* operates as a stand-alone device. The device reads 1D rack barcodes and single 1D barcoded and 2D Data-Matrix coded tubes (in 96-, 48- and 24-well format).
- The chosen area must not present a hostile environment to the device or its intended use.
- The device should be used in room temperature or within the specified operating temperature.




<u>WARNING:</u> Do not operate the device in an area with the following characteristics: high concentrations of dust, high humidity, explosion danger or toxic chemical storage.

3 QUICK GUIDE

For operators of the *Micronic Tube Reader DT510* who only need to know the daily operating procedure of the system, this chapter shows the sequence of actions that are required to use the *Micronic Tube Reader DT510* in the correct way.

3.1 GENERAL USE

- 1. Connect the Micronic Tube Reader DT510 to the computer via the USB-cable
- 2. Wait until the computer recognizes the scanner
- 3. Open the program in which you want to use the data
- 4. Hold a 1D rack barcode or a 1D barcoded or 2D Data-Matrix coded tube (any tube size in 96-, 48- or 24-well format) above the transparent plate. The *Micronic Tube Reader DT510* will scan and decode the rack or tube ID and export the code into the program which is activated on the computer.



4 TROUBLE SHOOTING GUIDE

The following Troubleshooting Checklist can help you to remedy certain problems that may be encountered when operating the Micronic Tube Reader DT510. The checklist contains the symptom, possible cause and corrective action related to the particular problem. Please note that this checklist is a general list and describes general known problems. Some problems might be solved when using a newer design/version.

Scanner is not recognized	USB port is not recognizedSurrounding lighting is abnormal	 Check in the device manager of the OS if the scanner is well recognized Put scanner in normal light circumstances
